In League of Women Voters parlance, "program" is a plan that sets out what issues the members want to study during the following year. In keeping with our non-partisan stance, we look at all of the aspects and both pros and cons. Members may attempt to formally take a position on which to lobby. Political agendas that are in the arenas of existing League positions also may come under scrutiny.

This year members will provide direction on Greater Tucson and Arizona League program position statements and potential studies. Planning is a crucial aspect of a local League's activity. The League's visibility and influence in the community are the result of local programs and action. It is important to find out where members' interests lie in order to work from common concerns in the group. The goal of this meeting is to identify interests.

Program is the basis for the League's education and action

efforts. Positions are added and amended only after members study the issue and reach agreement through a consensus or concurrence process. Action occurs when the League acts using one of these positions. Action can be taken only if a position already exists at the local, state or or national level and only by the president and board of the local, state or national League.

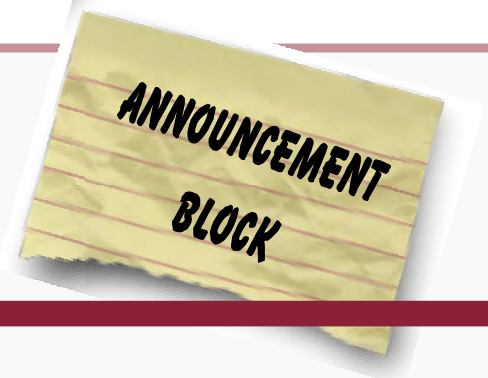

ARMS CONTROL UPDATE:

Sue Ward, 1st VP-Program, will give a short update on the LWVUS Arms Control position. This Update was adopted at the LWVUS convention last June.

The League's 1982-84 national security study was intended to add focus and direction to existing support for "efforts to reduce the risk of war, including negotiations on disarmament and arms control" under the UN position. The League has continued to play a key role in legislative efforts to limit funding for unworkable and destabilizing missile defense systems and to uphold the traditional interpretation of the

ABM Treaty.

Changes in the nature of international threats have played a great part in the current changes to the League position. For example, "non-state actors" weren't considered in earlier times; since 9/11, the existence of Al Qaeda has introduced an entirely new "actor" into the international picture. Other changes, too, have brought about the current updates to the League's position.

This is a year in which major treaties drafted in earlier years are due for review by the Congressional and Executive branches of government. As a result of this, the League has taken action to keep up to date with current arms control developments.

FINALLY, WE WON! VOTER ID LAWSUIT

On October 26th, a press release went out stating that the Ninth Circuit of Appeals issued a 2-1 opinion which found that Arizona's proof of citizenship law for all new voter registrants violates the National Voter Registration Act (NVRA) because the NVRA mandates that states "shall accept and use" the federal voter registration form without additional documentation requirements.

Leaguers should now get a lot of the federal registration forms to register new voters.

The LWV of Arizona joined with the Inter Tribal Council of AZ., Inc., the Hopi Tribe, Arizona Advocacy Network (AzAN), American Civil Liberties Union, AARP, and other organizations in a suit against this law.

Sen. Russell Pearce wrote the measure in 2004. It was put on the ballot and passed by 56% of the voters. At that time, it was the first law in the U.S. to require all would-be voters to prove they were U.S. citizens. Last year, the 9th U.S. Circuit Court met in Tucson with former Justice Sandra Day O'Connor as one of the three judges. Now, a year later, the decision has been reached with Justice O'Connor and Judge Sandra Ikuta voting for the decision and Judge Kozinski dissenting on the NVRA issue.

The Governor and Secretary of State have said they would appeal. You can be sure it will go all the way to the U.S. Supreme Court.

LEGISLATIVE REPORT

The election is over! All of the TV, radio and newspaper ads are done. The phone call will not be a ROBO call for a candidate. The signs are gone. Now we pick up the pieces and see what happened in our state and nation.

The U.S. Supreme Court will be hearing three cases on Arizona issues. On Nov. 3rd, it heard presentations on tax break donations for private schools which is church vs state. The case on matching funds for Clean Elections has not yet been granted a review but will be by December. The third issue is penalties for employers who knowingly hire illegal immigrants.

Women serving: Women did not do well this year. Depending on outcome of several races, women will hold even in the Senate with 17 seats and could lose one or two of their 73 seats in the House. This would be the first such decline since 1978. On the House side, the GOP fared better, adding 8 new female members but those gains were offset by defeats of at least nine incumbent Democratic women. The number of female governors will remain at six.

U.S. House of Representatives: The GOP picked up two new seats and held onto one. District 1 found (R) Paul Gosar over incumbent Anne Kirkpatrick (D); District 2: Trent Franks, incumbent; District 3: Ben Quayle (R); won the seat of retiring John Shadegg (R); District 4 Ed Pastor (D), incumbent; District 5: incumbent Harry Mitchell (D) lost to David Schweikert (R); District 6: Jeff Flake (R) incumbent; District 7: Raul Grijalva (D) incumbent and District 8: Gabrielle Giffords (D) incumbent.

State Legislature: This was fruit basket upset. Senators are now Representatives and vice versa. The GOP picked up three seats in the Senate and there are now 21 Republicans and 9 Democrats. Leadership positions were picked as follows: Senate Republicans: President-Russell Pearce (he was Speaker of the House last year); Majority leader-Scott Bundgard; Majority whip-Steve Pierce. House Republicans: Speaker-Kirk Adams; Majority leader-Andy Tobin; Majority whip-Debbie Lesko. Senate Democrats: Minority leader David Schapira; Asst. minority leader-Leah Landrum Taylor; Minority whip-Paula Aboud, Tucson. House Democrats: Minority leader Chad Campbell; Asst. leader, Steve Farley, Tucson; Whip Matt Heinz, Tucson.

Propositions:

Prop 106 Health Care Services: Passed with 55% of the vote (The LWV opposed this)
Prop 107 Preferential Treatment: Passed with 59% of the vote. (The LWV opposed this)
Prop 109 Hunting & Fishing: Failed by 56% of the vote.
Prop 110 State Trust Lands: Failed by 50.39% of vote
Prop 111 Lieutenant Governor: Failed by 59% of the vote.
Prop 112 Initiative Petitions: Doing recount as 50/50%
Prop 113 Secret Ballot: Passed with 60% of the vote.
Prop 201 Medical Marijuana: Passed by 50.13% of vote
Prop 301 "Growing Smarter" Sweep: Failed by 74% of the vote. (The LWV opposed this)
Prop 302 "First Things First" Repeal: Failed by 70% of the vote. (The LWV opposed this)

CHARTER SCHOOLS

The LWVAZ has a 1999 position on charter schools. Two years ago, the Tucson league decided to another look at local charter schools now they have been around about 15 years. We have researched both local charter schools and traditional public schools to see how successful charter schools have been, what effect they have had on the traditional public schools and what could be done to make things better.

We felt that it is important for everyone to see the 1999 position on charter schools.
SYNOPSIS OF LWVAZ POSITION ON CHARTER SCHOOLS

(Reached by participating AZ Leagues by concurrence in 1999)

LIMITATIONS

- Length of granted charter to limited to 5-7 years
- District schools' charter within own boundaries only
- Districts' charters in compliance with USFR (Uniform System of Financial Reporting)
- Number of schools chartered annually (no number given)

FUNDING

- Charters compliant with USFR
- Annual external financial review required
- AZ start up/stimulus funds eliminated
- Granted monthly on current enrollment
- Transportation formula consistent among charters and tied to actual expenditures for transportation Non-for-profit basis
- Non-compliance withholds funds and return of property to state

QUALIFICATIONS

Must include in charter and submit the following:

- A mission statement A sound business plan
- Curriculum Evaluation plan
- Governing board recruitment and procedures
- Compliance with AZ open enrollment law
- Maintain a proportion of certified teachers
- Require non-certified teachers to be similarly educated and/or experienced
- Require applicants (sponsors,) operators, governing board members, and teachers to be fingerprinted and background checked

OVERSIGHT

- Annual financial and academic review conducted by State Department of Education
- Non-compliance leads to involvement by State Department of Education
- Immediate closure in case of fraud, illegal use of money or abuse followed by charter school to arrange transfers of students

INPUT/INVOLVEMENT

- Mechanism for citizen involvement be integral part of governing boards
- Information regarding schools readily and easily available to public

VOTER SERVICES HIGHLIGHTS

■ Voter Services was very active in the greater Tucson community this past election providing and assisting with voter registration, political forums, speaker's on the ballot propositions, moderating community forums and providing training on how to plan and moderate forums. Shirley Muney directed forums; Martha Binns directed the Speakers Bureau and Sally Davenport chaired Voter Registration in the Library project. Gini McGirr conducted the most important task of creating the Voter Guides which so many folks in the community depend on to be educated on the ballot propositions.

■ This fall Shirley Muney, Sally Davenport, Noell Rodriguez, and Victor Bowleg provided a training opportunity for league and community members on the basics of planning and moderating a forum. This includes not only important information but actual role playing to familiarize the participants with all the tools needed to create future effective neutral forums.

■ Voter Service members conducted voter registration throughout the community.

At the 6th Annual Native American Family Wellness Day held at Pima Community College. Phyllis Wassenberg, Maryann Cuddeback,

Ginger Fetzer and Victor Bowleg registered over twenty voters. Sue DeArmond and Janice Rosenberg registered voters at the School for Integrated Academics and Technologies/Job Corps.

At a non partisan " Meet the Candidates" community program held by the Hispanic Chamber of Commerce and Latinos for Arizona Shirley Muney and Victor Bowleg registered voters.

■ Several successful forums were held this past election.

The Superintendent of Public Instruction Forum held at Rincon HS was a great learning opportunity. This forum presented us with several challenges in relation to auditorium size, security, demonstrator interruption, and moderator effectiveness, etc. These issues will provide an opportunity to improve future forums this spring with another training provided to the Tucson community on planning and moderating a forum.

Other candidate forums were for TUSD candidates, Amphi School District, Congressional District 7, Legislative District 26 (with 350 attending) District 27. Several were in Green Valley.

The Corporation Commission forum,

at the last minute, had only two candidates from the same party able to come. As a result, according to LWVGT forum rules, after each candidate was given time for a short opening address, the forum was canceled. This provided the public an intimate informal conversation with David Bradley and the late Sen. Jorge Garcia.

■ The Speaker's Bureau was chaired by Martha Binns.

Shirley Sandelands, Sally Davenport, Shirley Muney, Betsy Zukoski, Sue Ward, Marion Pickens, Phyllis Carnahan, Betty Geehan, Carol West, Carolyn Badger and Gini McGirr gave talks on the Ballot Propositions. These were at The Academy Village, AAUW, Colonia Verde Women's Assn., NorthWest Center, Catalina Village Assisted Living, Business Principals, and SaddleBrooke country club.
