National and Local League Program Planning

In League of Women Voters parlance, "program" is a plan that sets out what issues the members want to study during the following year, including ballot measures, proposals, and problems. In keeping with our non-partisan stance, we look at all the aspects and both pros and cons. Members may attempt formal consensus on an issue in order to formally take a position on which to lobby. Political agendas that are in the arenas of existing League positions also may come under scrutiny.

When there is a serious concern or conflict in our community, state or nation, we take it as our responsibility to become better informed citizens, which can be a worthwhile end in itself. More often, we share the information we get with the public through various means, including forums featuring experts and our general meetings, which are open to the public.

WHAT ARE YOUR BURNING ISSUES?

January is the month in which we begin to plan our program for the coming year by examining local League positions. In alternating years we also review state and national positions. In 2010 we review national positions in preparation for the June 2010 League of Women Voters National Convention. Local planning is a crucial aspect of a local League's activity. The most successful Leagues offer interesting, stimulating and relevant local programs.

The League's visibility and influence in the community are the result of local programs and action. Program planning is your chance to let the Board know what issues are important to you.

The Program committee sees this as an opportunity to address our many concerns for our local community and our nation. Wouldn't you like to see LWVGT step up in support of an issue that is dear to your heart? Expressing your interests at this meeting will NOT commit you to chairing a committee. We hold the programming meeting because we think it is important to find out where members' interests lie in order to work from common concerns in the group. There will be no agonizing over how to fund activities or who will be responsible. Those questions will be dealt with eventually, but the goal of this meeting is simply to identify interests.

INSTRUCTIONS FOR COMPLETING THE PROGRAM PLANNING FORMS:

*Mark **Retain** if you wish to keep the position unchanged.

*Mark **Drop** if you wish to delete any portion or all of the position.

*Mark **Update** if you wish more current information on this position.

* Mark **Restudy** if you believe the position needs a new or different consensus.

At this time, we also look at issues we have not studied. Look around your community and nation. Are there issues that a government entity can address?

Mission Statement

LEGISLATIVE UPDATE

MERIT SELECTION: The University of Denver's Institute for the Advancement of the American Legal System (IAALS) whose core mission is to improve the process and culture of the civil justice system so it is accountable to and trusted by those it serves.

The Institute will launch its Judicial Selection Initiative on December 8, 2009. This is to foster change in judicial selection systems nationwide to the appointment, evaluation and retention election model. This will provide states interested in moving from direct election to judicial selection with tools to achieve that goal and to provide states in danger of losing the retention process with tools to combat attacks on the system.

The Advisory committee: Chairwoman: **U.S. Supreme Court Justice Sandra Day O'Connor**, IAALS Executive director and CO Supreme Court Justice Rebecca Love Kourlis (retired), Meryl Chertoff, Chief Justice Wallace Jefferson, Chief Justice Thomas Moyer, Larry Thompson, GC PepsiCo, Tommy Wells, former Pres. American Bar Assn., **Chief Justice Ruth McGregor**, (retired) (AZ), and **Mary Wilson**, **President of the League of Women Voters of U.S.**

LWVUS: Mary Wilson, president, LWVUS, issued a press release on Nov. 10th applauding the House for passing the Affordable Health Care for America Act (H.R. 3962) on Nov. 7th. However, the League was disappointed in passage of the Stupak-Pitts amendment, which not only prohibits abortion coverage in the government-run plan but prevents any private plan from offering abortion coverage to plan participants if even just one individual in that plan used government subsidies. The League hopes the Senate will do the right thing and pass health care reform legislation without such language and with a strong public option.

AZ LAWSUITS: An Administrative Law Judge issued a ruling on Nov. 9, stating that he found the testimony that Rep. Doug Queland (R-10) provided was not credible enough to recommend against the Citizens Clean Elections Commission. The Commission had found that Queland had exceeded his campaign expenditure limits and made decision to force the lawmaker from office and pay \$45,000 in restitution. Will see where it goes from here.

The governor signed S1123 into law which bans local governments from including partisan affiliations for candidates on the ballot. It also has citizens only voting for candidate in their ward. The Tucson City Council filed suit as thinks the legislature should not impose its regulations on how the city runs its elections. Previous AZ Supreme Court precedent holding that the city's charter supersedes state law in local election matters.

The governor signed H2101 which would increase the Pinal county board of supervisors to five members from two members. A Maricopa County Superior Court judge overturned this legislation. This was an attempt to immediately increase representation on the Board and give the candidates a "leg up" on 2012 elections. This will cost the county \$30,000 in legal fees which is a shame given the fact the Legislature was responsible for passing a clearly unconstitutional law.

Voter ID suit was heard by 9th Circuit court of Appeals on Oct. 20th but no ruling has yet been posted.

New suit by the League of AZ Cities and Towns, Nov. 6th, went to court to stop several new laws that seem to have been adopted illegally during the last special session. These include a two-year moratorium on new impact fees from municipalities and a mandate that all local governments verify the immigration status of anyone seeking public services.

IMMIGRATION: Sen. Russell Pearce, Republican from Mesa, held a press conference stating that the state's top priority is illegal immigrants and plans to strengthen the laws. If the reforms are not

adopted by legislature, he stated he will put a citizen initiative on the ballot.

SPECIAL SESSION: The governor called a 4th special session in November to work on portions of the Budget. This included \$144 million in cuts to K-12 education. This law stripped educators of some protections that their employers have afforded them for years. There was a big cut in the Dept. of Economic Security. Also changes that will allow several state agencies, including the Dept. of Revenue, to access their funding sources. It sounds as if there will be another special session in December. This could be discussion on how legislators could get voter protected funds.

LEGISLATIVE COUNCIL: Nov. 15, Prefiling begins; Jan. 11, 2010, Session begins; Feb. 1, Last day for Senate bills to be introduced; Feb. 8, Last day for House bills to be introduced.

A JOINT LEGISLATIVE PANEL approved a recommendation on Nov. 9 to extend the Dept. of Health Services, which was the subject of a sunset review, for another decade. The Dept. has asked for funds from the Early Childhood Development and Health Board but this Board states that the money should not be diverted away from the purposes for which the program was created. They said that state law does not permit the money to be used to supplant state funding as it comes under Prop 105, the voter restriction on funding. The Legislature previously swept the fund's interest earning as part of a budget adjustment early this year, the board filed a legal challenge and won.

CANDIDATE SEASON FOR GOVERNOR BEGINS: Gov. Jan Brewer has filed and will run under the Clean Elections provisions. John Munger, Tucson attorney, has filed and is running traditionally and has taken the governor to task for "running on taxpayer funds." Paradise Valley Mayor Vernon Parker has filed an exploratory committee and plans to run as a CE candidate. Dean Martin, state treasurer, has said he is considering running but hasn't said if he would run clean or traditional, though he ran traditional for treasurer's office in 2006. Phoenix businessman Robert Graham's name has been mentioned to run for this job.

Libertarian candidates are Bruce Olsen, Overgaard, who has filed. Barry Hess, who ran in 2002 and 2006, plans to file paperwork in the next few weeks. Another name is former Graham County Sheriff Richard Mack who ran as a Libertarian against U.S. Sen. Jon Kyl in 2006, but he may run as a Republican or an independent.

The name of Attorney General Terry Goddard, Phoenix, has come up for Democratic slate.

STATE LAWS: Just to make you feel cared for, 160 NEW laws took effect Sept. 30. Taking guns into restaurants and bars is now legal. Two laws that were intended to put additional restrictions on abortion were slated to take effect, but a judge has granted an injunction until the court decides on legal challenges to the laws. There are 20 suits against the legislature on budget actions. The newest ones are AZ Education Association and the League of AZ Cities & Towns.

PAYDAY LOANS: Another issue that League members must be watching is to make sure that the sun sets on AZ payday loans. This was voted on last year and will be gone next July 1st unless lobbyists convince legislators to extend or remove this sunset date. These high interest loans do not benefit the consumer, the economy or the state.

NATIONAL WOMEN'S HISTORY MUSEUM UPDATE

On Oct. 14th, the House of Representatives finally voted and passed the on site legislation, HR 1700. This had been introduced over a year ago. Then on Oct. 29th Sen. Susan Collins (R-ME) re-introduced the companion bill, S 2129, in the Senate and it is now in Committee. When this passes, the group will be on the way to building a world-class Museum in Washington, DC at 12th and Independence Ave SW adjacent to the National Mall. This lot is across the street from the National Air & Space museum. Since it involves federal property, it has to be approved by Congress.

When the Senate bill is passed, we will have three years to raise the money to purchase the land that has been granted. The top museum design firm, which did the Holocaust Museum has been hired. If the money is not raised, Congress will take the land back.

This is to secure permanent physical space to house the collections that NWHM plans to make public and further its educational services. The museum will show the many accomplishments and contributions that women have made to our nation.
